E. <u>Legislative Committee</u> – (Administration)

The Governor's office recently released new school funding distribution totals based on increased appropriations made to the school funding formula. In total, almost \$8.5 billion will be disbursed to the state's 577 school districts, including an additional \$68 million to bring aid in balance for underfunded districts.

- \$195 million in extraordinary special education aid that is provided through an
 application process to reimburse districts for eligible high-cost special education
 services;
- \$5.4 million for the nonpublic technology initiative, an increase of \$2.4 million;
- **\$2 million** in funding for a new Secondary School Computer Science Education Initiative, which will support advanced computer science course offerings;
- \$400,000 for STEM Dual Enrollment and Early College High Schools; and
- \$750,000 for a new High Poverty School District Minority Teacher Recruitment Program

The Murphy Administration recently announced first steps in transitioning away from the PARCC assessments and toward a new generation of statewide testing through a report, detailing proposals for draft regulations and other upcoming changes in the 2018-2019 school year.

- Streamlining graduation requirements by reducing the number of required test in high school from six to two.
- Ensuring that educators and parents receive test data in a timely manner.
- Providing flexibility for first-year English learners on the English language Proficiency test.

- Reducing the length of testing for all grades by approximately 25 percent.
- Reducing the weight of the assessment on teacher evaluations.

The New Jersey Department of Education today applauded New Jersey schools for achieving top Scores as reported by the National Assessment of Educational Progress (NAEP). According to the 2017 NAEP data, New Jersey's fourth-grade students' scores were tied as the highest in the nation in both reading and math, and the Garden State's eighth graders' scores were tied for second in the nation in reading and math.

A sweeping study by a panel of tax experts and economists for how to improve New Jersey's fiscal stability includes a recommendation to curb rising property taxes and make local government more efficient calls through the elimination of nearly half of the state's nearly 600 school districts.

In Bergen County, all of the k-8 districts are on the list, Midland Park is not.
