## PRESIDENT'S REPORT

#### **Mission Statement**

We are planning to have our next Board meeting on April 6 in person. The location of the meeting will be in the HS Gymnasium, the public will use the front entrance of the school to enter the building. If the HS Gym is not available, the meeting will be held in the Highland School Gymnasium.

## SUPERINTENDENT'S REPORT Dr. Marie Cirasella

- Basketball games are being played in our schools and district custodians remain on site and proper cleaning protocols are being followed.
- The PK-8 component of our Phase II re-opening plan began this week and went very well in all schools. The implementation of Phase II for students in grades 11-12 began yesterday and students in grade 9-10 will be begin on Monday, March 22.
- On March 9, we received notification that the County of Bergen, in conjunction with Bergen New Bridge Medical Center, is rolling out a preliminary plan to vaccinate school employees. The County is offering 800 doses of the Johnson & Johnson vaccine on Saturday March 13, to a group of pre-determined school employees, from districts in Bergen County.
- Working with MPEA leadership, all district employees were contacted to ascertain interest in receiving the vaccine. A random selection process, using a computerized program. This process was videotaped. The administrative team is working to support all staff members in getting vaccine appointments. Thank you to several MPEA colleagues who have been very helpful, working from their homes, to find appointments for district staff. The following was eblasted to district staff:

Valley Health System is proud to announce that next week, dependent upon supply, its Vaccination Center, located at 599 Valley Health Plaza in Paramus, will dedicate vaccines to all personnel who are employed by area schools, as well as licensed childcare providers.

Mr. Canellas made a statement regarding the audit. He referred to Mr. Higgins report and that their finding is correct but he stated that the auditors tested the internal controls and those controls ensure that contracts and awards are properly encumbered. The funds that were not encumbered was an isolated incident that happened at the very end of the fiscal year and at the end of an unprecedented year when COVID caused the staff to be in and out of the office. Mr. Higgins was remiss in giving the background and there were mitigating circumstances to this finding. I would like to thank Ms. Garvey and her staff, I can't imagine doing an audit after these circumstances.

Ms. Garvey added that the Business Office brought this to the attention of the auditors to ensure the district had the money available for us in the following school year for building projects slated to be done over the summer and it didn't fall into surplus or go back to capital reserve. Ms. Garvey also thanked the Business office staff.

- E. <u>Legislative Committee</u> (Administration)
  - We are beginning preparations for meeting the mandate of NJ State Assembly Bill No. 4454, which requires school districts to include instruction on diversity and inclusion as part of implementation of NJ Student Learning Standards for grades K-12, beginning in the 2021-2022 school year. (The previous format included grades 9-12 only.) The bill is designed to "Promote economic diversity, equity, inclusion, tolerance and belonging in connection with gender and sexual orientation, race and ethnicity, disabilities and religious tolerance. These standards will be woven throughout the curriculum in grade appropriate ways, resources have been purchased for the elementary media center, social studies will include references to the contributions of these individuals, etc. We understand this is a controversial topic, at this time there are no provisions for requesting children be excluded from receiving this content.
  - On June 3, 2020, the NJDOE adopted new learning standards for teaching Health/PE. Part of these revised standards for 8<sup>th</sup> grade include 2.1.8.SSH.9: Define vaginal, oral and anal sex. We anticipate additional concerns being raised with regard to these NJSLS revisions and will closely monitoring information from the county office, communicating as much as we know about this issue to school families.
  - On February 22, Governor Murphy made history when he signed a bill into law making marijuana legal in NJ. There was an outcry to one of the provisions in the law which states that parents will not be notified if their child is found by police with marijuana or alcohol for a first violation; but will be notified on the second violation. On March 15, the Governor said he agreed with making changes to NJ's new marijuana law, particularly on the issue of when police can notify parents if their underage child is found with marijuana or alcohol, the Governor supports the parent notification at the first violation.
