Mr. Schiffer spoke on the tentative budget being presented. He asked that everyone realize that this is a Tentative Budget. It is the intension of the Committee to work further on budget in order to reduce the increase, but had to submit something for approval because the initial budget is due to the county office.

Mr. Venditti stated that he is concerned with the increase. He commented that the current environment impacts everyone. We are trying to educate the children, they are our future, but he does not want the public to think we are insulting them with the increase presented. He wanted the committee to know his concerns.

Mr. Schiffer commented that starting 5 years ago the State began pushing State Aid figures to March but still required Budget submission on same date, We now have to rush to put something together within a week and continue working up to the Budget Hearing. We have no problems comparing this District's education program to any other. Large amount of Free Balance was given back to keep tax levy down long before State sets rules. There is an awareness of the current economic situation however; we must also know how deep we can cut our budget comfortably. The average home cost is \$300,000 and is an increase of \$272 annually or \$23 a month.

Mr. Canellas asked when the Board will have numbers that will be presented at the Public Hearing?

Mr. Schiffer answered that by Friday before the Public Hearing, if not sooner.

There was discussion on the number of sections budgeted for next year's third and fifth grades. Mr. Schiffer advised that at this time there is an extra section budgeted for the third grade and half time for the fifth.

D. <u>Policy Committee</u> – (P. Lein, Chairperson)

Ms. Lein reported that many policies are being reviewed. There will be many for the Board to approve.

E. <u>Legislative Committee</u> – (J. Canellas, Chairperson)

The following items were reported on:

S15/A3650- Passed by both the Senate and the House. The bill would allow for a reduction in state aid equal to the amount a district would save by deferring half of its Public Employees Retirement System current year contribution.

S2647 – Released by the Senate Education Committee on 3/9. The bill would require criminal history checks for school district volunteers who have regular unsupervised contact with students. Identical Bill A3813 was referred to the Assembly Education Committee on 3/5.

S1007 – Released by the Senate Education Committee on 3/9. The bill would require school districts to report to the Department of Education information on students who are removed from school pursuant to the "Zero Tolerance for Guns Act." Under the bill, districts must annually report violence and vandalism incidents. The bill also provides for formal recognition of effective intervention programs, making information about the program available to all districts in the state.

A3222 – Reported out of the Assembly Education Committee on 2/26. The bill would establish temperature control guidelines and standards for school facilities. Under the bill schools would be required to keep the temperature of the building between 68 and 79 degrees, with schools required to evacuate students if the temperatures fell below 63 degrees or rose above 89 degrees.
