#### E. Legislative Committee – (Administration)

- Arbitration for non-teaching staff members: under this revision, a non-teaching staff member now has the right to submit to binding arbitration any dispute regarding there is just cause for disciplinary action, including, but not limited to: reprimands, withholding of salary increments and termination or non-renewal of an employment contract. The employee may submit to such arbitration irrespective of the employer's action or failure to act, and of any contracted or negotiated provision. The burden of proof shall be on the employer to demonstrate just cause.
- Substitute teacher requirements: candidates for a substitute teaching credential who apply between May 11, 2021 and June 30, 2023, need only 30 credits and need only be 20 years old. During a period of public health emergency, substitutes can fill positions for up to 40 school days, plus an additional 20 school days, upon approval of the Commissioner.
- Parental notification of marijuana offenses: Law Enforcement is now required to provide a written warning to a minor and written notice to the parents of the minor charged with purchasing, knowingly possessing or consuming alcohol or cannabis in any school, public conveyance, public place, place of public assembly or motor vehicle on the first violation. The prior language indicated this would not occur until the second violation.
- Anti-Hazing Bill: This bill is to combat hazing among middle and high school students and college students and was inspired by the tragic death of NJ student Timothy Piazza who took part in a fraternity pledging process at Penn State University. The bill requires institutions of higher education and public and nonpublic schools and middle schools to adopt anti-hazing policies, expands activities encompassing criminal hazing and upgrades penalties for engaging in these activities. A policy draft is to be provided to us shortly for the Board's consideration.
