  - New Jersey's Anti-Bulling Task Force took testimony during the first week of October in two public hearings, one in person and one virtual. The purpose of these hearings was to provide stakeholders the opportunity to share experiences regarding the implementation of the Anti-Bullying Bill of Rights Act in the state's schools.

The Anti-Bullying Task Force is charged with examining the impact of New Jersey's Anti-Bullying Bill of Rights Act and making recommendations for improving the way acts of HIB are addressed in schools.

New Jersey's Acting Commissioner of Education Dr. Angelica Allen-McMillan, spoke to the work of the task force in noting, "The input of people who have been most affected by bullying is crucial to inform the work of the task force. The recommendations of the task force can provide legislators the direction needed to ensure students have access to a safe and supportive learning environment." The task force will report its findings to the Governor by the end of the year. We will keep you posted as to any further developments in this area.
