Mr. Sullivan asked Ms. Garvey to explain the refinancing of the Bonds and the Ordinance. Ms. Garvey explained that the auditors reviewed the districts outstanding debt and discovered that if the 2005 bond referendum was refinanced, there would be an estimated saving of greater than 3%. In as much, according to state regulations, the district must refinance. The savings gets directly passed on to the taxpayer due to the decreased amount necessary for the debt service payment. The total savings is spread over the remaining payback years or until 2023-24.
